President's Report

The **goals** I set for my presidency were to: 1) continue making progress with the Strategic Planning process; and 2) have a new website that is user friendly, meets goals of Strategic Planning initiatives, and offers new things to Members. I am pleased to see that we have met these goals.

At the recent GLR conference in Minneapolis, members of the GLR Executive Board met with Bill Hogan, our Strategic Planning Consultant from San Antonio, Texas. He worked with us for over $3\frac{1}{2}$ hours on the Thursday of conference to continue to develop a strategic plan for the GLR. Much progress was made, and we are currently in the process of documenting the goals, objectives, action steps, timelines, and responsible parties in the written strategic plan. This will then guide us as we move forward in working on the goals we have set. More information will be provided in the future as things progress.

During the last two years we have created a new logo and launched a new website that has more updated information on it, as well as a Members Only section. Once a few more things are worked out, we will also be launching our new Mentorship program via the Members Only section. In addition, our most updated Mission and Vision statements are on the website, and I will provide them for you here. Once you read them I think you will see that the two goals I mentioned above are interconnected.

- **Mission:** The mission of GLR is to advance and support the mission of AMTA (advance public awareness of the benefits of music therapy and increase access to quality music therapy services in a rapidly changing world) on the regional level and to serve GLR-AMTA members.
- Vision: By 2018 we will be the resource for members in our region for information that meets their needs.

In addition to the goals I had above, I worked on a variety of other things as well. Some of these things included encouraging the EC to share reports via Dropbox, conducting regional business with the Executive Board via email and conference calls as necessary, submitting President's letters for the *Voice of the Lakes*, submitting President's reports to AMTA twice a year for inclusion in their Board of Directors books, following up on any requests and questions raised by AMTA, submitting President's reports and information to AMTA for the 990 and working closely with AMTA Executive Director Andi Farbman, the AMTA Accountant, and GLR Treasurer Stephanie Harris to correct and complete it each year. I also met with the Presidents from the other regions via email, conference calls, and during the Regional Presidents meeting at the AMTA conference. This connection has been extremely important and helpful as many of the same questions and concerns are raised in all of the regions.

President's Report (continued)

I also spoke with several of the GLR officers, standing committee, appointed committee chairs, and conference co-chairs on pertinent topics and provided assistance and input as needed. I responded to many questions, phone calls, and emails regarding GLR business; and I was honored to preside over the GLR Executive Committee meetings, the General Business meetings, and the Awards Luncheon at the GLR conference.

While I was in Minnesota I had the pleasure of visiting Christina Wood and having a tour of Mayo Clinic. She and I then went to KXLT Fox47's studio where we were interviewed about music therapy by Nicholas Quallich. The segment appeared on the Fox47 morning show on Friday, April 10th. If you would like to see the interview, the link appears on the GLR website and Facebook page. This was also shared by AMTA, and by many other music therapists via Facebook, Twitter, etc.

In the GLR EC meeting we also made some financial decisions, which I would like to share with you. As you probably know, we are financially secure, and because of this we like to be able to give back to our members and to support various efforts within our profession. Therefore, we decided to donate \$1,000 to AMTA to cover the full cost of a jam room at the 2015 AMTA conference. This not only provides financial support, it also supports the making of music, which is so very important to us as music therapists. We also decided to donate \$2,000 to AMTA toward the State Recognition Operational Plan. At least 4 of the 6 states in our region are working on some type of legislation efforts; therefore, we felt that as a region it was important to support these ongoing efforts and the assistance provided to all of our states by Judy Simpson and the rest of AMTA. In addition, as part of our continuing efforts to support our membership, the GLR Executive Committee decided that we will keep rates for next year's GLR conference the same. Although costs to put on a conference continue to rise, we feel that keeping rates low is a way to give back to our members.

I have been honored to serve as your President over the last two years, and I appreciate all of the support you have provided me along the way. Thank you for everything! I look forward to moving into my role as Past President and working with Larisa as she takes over the presidency. I know that she will do a wonderful job!

Membership Support:

I created a membership support application form, which the EC recently approved. It contains policy and procedures around applying for/receiving membership support, and it is included at the end of this issue of the Voice of the Lakes (page 42).

Procedure and Timeline:

- 1. Complete this application.
- 2. Submit to the current Past President of GLR of AMTA. You may submit an application at any point during the year.
- 3. Applications will be considered by the EC at the national conference (October/November) or regional conference (March/April), immediately following the application.
- 4. In some cases applicants cannot wait for the next conference to receive a decision, due to impending deadlines (e.g., CMTE registration). Applications marked "Time Sensitive" which arrive between conferences, will be considered as soon as possible, via phone conference or electronic means.
- 5. Applicants will be notified within one week after the application is voted upon by the EC.

Officer Handbook:

I will work with Angie Snell on completing this task. Please, as you transition OUT of your current EC role, type a simple document stating 1) each duty you were in charge of in your officer role, and 2) a timeline of when those duties were accomplished throughout the year. Assembly Election:

In odd numbered years the GLR of AMTA elects new Assembly delegates to serve in the next cycle (which begins in the following even numbered year). Therefore we will hold elections this summer for the Assembly that serves in 2016-2017. At the GLR conference in Minneapolis, we accepted nominations from the floor during our second general business meeting and these nominations form the slate found on the next page. The GLR of AMTA has 15 seats on the AMTA Assembly of Delegates. We will vote for 14 delegates because our new President of GLR, Larisa McHugh, is automatically one of our delegates on the Assembly per our bylaws. These people are your representatives to the Assembly and you should feel free to connect with them to let them know your opinion on issues that will be discussed and voted upon in Assembly. If you are elected as a delegate you need to be present for the new Assembly orientation at the <u>2015 AMTA conference</u>, and to serve on the Assembly in <u>2016 and 2017</u>. Fifteen alternates will be determined according to greatest number of votes and will be called to serve in cases where delegates cannot serve. <u>Please ensure that your email is correct with AMTA Office so you will receive the Survey Monkey invitation to vote in this election</u>.

<u>Bylaws-</u> the following changes were approved and made during the 2015 GLR conference. The changes are to reflect AMTA bylaws regarding membership.

Section 9. Members who pay membership dues after October 31 will be considered members for the following calendar year unless they request otherwise.

Section 12. Members failing to pay dues by April 1 shall forfeit all rights of membership, including receipt of the <u>Voice of the Lakes</u>.

Vice President Elect's Report

In order to serve the members of the GLR better, I conducted a survey to find out their preferences and thoughts about where conferences are held and what is being offered. The survey was sent out to the 4th quarter GLR membership list and saw a 41% return rate. The results were as follows:

- 1. Which type of location appeals to you most?
 - a. 62% City (shopping, maximum food options, close to airports, but possibly higher hotel rates and parking fees)
 - b. 31% Smaller Town (minimal food, activities, but lower hotel costs and parking fees)
 - c. 7% other
 - i. Easy access to flying
 - ii. Large suburbs
 - iii. Places that have food options in walking distance
- 2. What events, outside CMTEs and sessions, would you most likely attend at a conference?
 - a. 49% may attend Population Specific Roundtables
 - b. 47% Jam Sessions
 - c. 62% Pre-planned trips to event/location
- 3. Other suggestions to make GLR conferences better?
 - a. Another combined conference with the Midwest region
 - b. Better deal on CMTEs if you buy more than one
 - c. Keeping costs down

In addition to the survey, I have been looking for more ways to update the forms the cochairs receive and make them more clear. I have already talked to the co-chairs for this current conference about discussing what issues they had during the planning process. One of the things that I would like to do is combine all of the thumb drives from previous conferences and create a google drive to make transitions between co-chairs more smooth.

Illinois State Report

Membership:
IAMT has a total of 112 members:
68 professional members
3 interns
2 student groups with a combined total of 41 student members

Financials:

IAMT is currently in good financial standing and our accounts are balanced with our bank account at \$11,317.38 and PayPal at \$2099.17.

Programming and Continuing Education:

The spring CMTE focused on Advocacy. On March 15th, therapists participated in an advocacy webinar and then attended Hill Day on March 18th to meet with legislators about our licensure bill. This was a well-attended event. The board plans to offer a CMTE this fall focused on clinical improvisation in music therapy.

Government Relations/State Recognition Task Force:

The Illinois Task Force for State Recognition has been very active pursuing licensure for Illinois music therapists. Both Senator Dan Kotowski and Representative Michael McAuliffe filed bills for licensure in March. To gather support from Legislators, the Illinois Association for Music Therapy (IAMT) and the Task Force held an Advocacy CMTE and Hill Day in Springfield where over 30 music therapists and students connected with EVERY legislative office, educating about music therapy and asking for support of our bills. Despite a huge gain of supporters and hours of work by the music therapy community, our bills had significant opposition from the Department of Finance and Professional Regulations (DFPR). The department stated that Illinois is currently trying to de-regulate professions and the state is not licensing any new professions, especially those with small numbers like music therapy. The cost for a license would be astronomical. The DFPR was not willing at this time to come to an agreement and work with cost effective solutions proposed by CBMT/AMTA. Senator Kotowski and task force members had several (sometimes heated) calls with the DFPR to see what could be done to help our profession move forward and receive some type of state recognition. Since licensure is currently off the table for this legislative session, Kotowski's office has recommended creating an official Music Therapy Act that would recognize the profession of music therapy in state language. This act would contain AMTA's official definition of music therapy and language from CBMT of who is qualified to practice music therapy. Senator Kotowski believes this Act will be a good first step towards licensure in the future.

Illinois State Report (continued)

The spring newsletter for IAMT included tips from Task Force Chair, Nancy Swanson, on how to respond to instances where music therapy is misrepresented. Music therapists were provided with language to use when confronting individuals and providing education on the profession.

Public Relations:

IAMT sponsored a table at the Illinois Music Educators Association (IMEA) Conference this past fall. Several Illinois music therapists volunteered to staff the event and had an opportunity to connect with many high school students.

Student Affairs:

IAMT had a successful student retreat on February 28, 2015. It was hosted at Western Illinois University, and there were close to 20 students attend the retreat! IAMT was excited to host Debbie Bates, MM, MT-BC, Janel Cross, MT-BC, Lauren Jacob, MT-BC, and Dr. McGowan. The topics were ethics, first year on the job, and the ukulele. The day was interactive, and WIU and ISU students were able to meet and discuss ideas with each other. The IAMT student scholarship application is out, and we are hopeful that we will have several applicants. The scholarship this year will be given to the student(s) who design a compelling a t-shirt for music therapy advocacy.

Clinical Training:

There are currently thirteen approved internship sites in the state of Illinois. Two of these sites are University affiliated, eight are active, and three are inactive. It is a goal of IAMT to increase the number of internship sites within the state of Illinois. IAMT members will be receiving a survey within the next month that will provide the board with valuable information on what is working and not working at the existing sites within Illinois.

Other Business:

Fair Salary Committee

An ad hoc committee has been established to examine the issue of fair compensation of music therapists in Illinois. The Fair Salary Committee is chaired by Beth Belouf and is in the process of creating a survey to send to IAMT members in order to gather information on compensation and fee structures. Future goals of the committee include sharing survey results with state members, providing education to music therapists on setting competitive rates and educating employers in Illinois on fair compensation for music therapists. The committee hopes to gather more detailed information than what is provided by AMTA on average salaries, taking education, geographical area, additional training & credentials, job description and years of experience into account.

Illinois State Report (continued)

New Scholarship Opportunity

IAMT is pleased to announce it will be offering 2 IAMT Members a free IAMT sponsored CMTE experience inn 2015. All applicants must be 2015 IAMT Professional Members. Applications will be submitted to the Past President and must include a statement of need and description of potential professional development. One award was granted for the spring CMTE.

Non-Profit Status

The board continues to work on achieving non-profit status. After the tax season, the Past President will be consulting with an accountant to gather insight and advice on completing the application. Consultation with other state presidents has been very helpful throughout this process.

Membership

Past Meetings

On March 28, 2015 we hosted our spring meeting at Indiana Wesleyan University. We had 9 students and 10 professionals attend 2 presentations. Clinical Training/ Internships

AIMT recently awarded our 2015 student scholarship to Emily Hurst, a student from IUPUI, during the Indiana state meeting at GLR. This is intended to aid students who might need financial assistance during their internship. The scholarship is available to any student in an Indiana music therapy program.

Indiana currently has five active national roster internship sites: Bi-County Services, Opportunities for Positive Growth, Meaningful Day Services, Season's Hospice, and State of the Heart Hospice. In addition, our state now has five institutions educating future music therapists: Saint Mary of the Woods College, Indiana University Purdue University-Indianapolis, Indiana University Purdue University-Fort Wayne, University of Evansville, and Indiana Wesleyan University.

Public Relations

AIMT has started sending out regular newsletters again in the past year. During the latest newsletter, January 2015, we spotlighted out first 'Featured Music Therapist', Casey DePriest. This is a section we would like to include in every newsletter. We have placed a form on our website for anyone to access in order to nominate a music therapist they would like to see featured. Indiana State Report (continued)

Website

AIMT recently appointed a new Webmaster, Caitlin Krater, to oversee our website. Over the past year, we have consistently been receiving new postings for job opportunities all over the state of Indiana. State Task Force

The Indiana State Task Force has been following HB 1303, Registry of Certified Professions. This bill establishes a procedure for individuals and existing licensing boards to apply to the professional licensing agency to allow qualified individuals to become state certified and be placed on the electronic registry of professions. Prohibits an individual who is not state certified from using the title "state certified". We have been testifying in favor of this bill and advocating for specific music therapy language to be included. AIMT Past President Lindsey Wright and AIMT Vice President have both provided testimony in favor of this bill. This bill was passed out of committee and was passed by the Senate by a 45-5 vote. It has now been sent back to the House for further consideration.

Membership:

Task Force Update:

This year, the state task force has been working with the newly elected congress in drafting new language for our music therapy licensure bill. With the election, the bill that was heard last year in senate committees are nullified and the process begins again with new bills, bill authors, and hearing deadlines. We are close to having the final language drafted to best reflect what we learned last year about specific legal language, to address concerns brought forth from other professions, to most accurately represent our profession, and, most importantly, best protect our clients. We hope that we have new bills introduced soon.

Through this process we have also had to find new authors for our bills. Rep. Dorholt was not re-elected so Rep. Jennifer Schultz has agreed to author our bill in the House. Although Sen. Rosen is still a great supporter of music therapy, she thought it would be more politically appropriate to have a new author on the senate side. Sen. John Hoffmann, who authored last year's bill to add music therapists to the teacher bargaining unit, has taken up licensure for us in the senate.

We are excited to have these bills be introduced this year and plan to push for committee hearings during next year's session! We recognized several senators and representatives of friends of MTAM at the GLR Conference award luncheon.

Wisconsin State Report

Bylaws – We reviewed our bylaws in January 2015. We have taken steps to amend a current section of the bylaws. The amendment is due to the addition of the Fundraiser Chairperson position being added. An email was sent to current members of WCMT to review the bylaws prior to the voting of the changes.

Public Relations – We recently celebrated Music Therapy month with an official proclamation from Governor Walker. The WCMT membership voted on a second annual music therapist of the year, Richelle Kroening who will be awarded with a \$100 gift card to West Music and one year's free membership to WCMT. We are also in the process of coordinating volunteers to staff an exhibit booth at the Autism Society Conference at the end of April in Wisconsin Dells.

Continuing Education – On April 22, 2015, a CMTE was held in Madison to support Hill Day at our capitol. The agenda included a meeting with legislators, and discussion of current issues dealing with IRIS/Family Care, mental health and the Music and Memory Initiative. On October 17, 2015, a CMTE will be held in Madison entitled "Innovations in Music Therapy Interventions." This CMTE presented by Laurie Farnan, will be a diverse program covering several topic areas with innovative ideas for development of effective intervention strategies. Multi-sensory stimulation and processing techniques including tours of black light room with glowing instruments will be on the agenda along with covering strategies for using current popular music (Grammy tunes) in goal based session planning. There will also be the examination and demonstration of simple and effective instrument adaptations of common rhythm instruments, and an exploration of the nationwide trend of music therapist partnering with symphony orchestras for mutually beneficial experiences in community engagement initiatives in health care settings.

Government Relations – An email was sent to current WCMT members to inform them of some of the proposed major changes to Long-Term Support such as IRIS and Family Care. Governor Scott Walker's budget proposal would cut IRIS, a long-term care option for people with disabilities and the elderly, and change how Family Care is implemented. These programs would no longer be a part of the Department of Health, but rather fall under the Office of the Commissioner of Insurance. This implementation would change the focus from being quality of life/self-directed model to a more medical necessity model. This change could lead to a great impact on the opportunities of consumers accessing music therapy services.

Wisconsin State Report (continued)

Webmaster - Our Webmaster has been busy on a monthly basis sending out to our membership "Music Therapy Intervention Share" submitted by current WCMT members. The intervention shares are a good resource for a variety of populations and full of fresh ideas. These intervention shares are a great benefit of being a WCMT member.

Membership - We currently have 55 professional members and one student member. The ongoing membership enrollment is a great change but also confusing for people to keep track of what day they paid last year. We are currently working on ways remedy this to maintain high membership numbers.

Government Relations Report

Angela Snell

<u>Overview Statement:</u> Music therapists across the country are actively involved in advocacy on the state and federal level designed to raise awareness of the profession and increase access to quality services.

Each GLR-AMTA state chapter has an active Government Relations Task Force except for Wisconsin which functions efficiently as their own Task Force and original role model for the many of the state Task Forces. See state reports for government relations and Task Force updates.

STATE REPORTS

Illinois:

Illinois Task Force for State Recognition has been very active pursuing licensure for Illinois music therapists. Both Senator Dan Kotowski and Representative Michael McAuliffe filed bills for licensure in March. To gather support from Legislators, the Illinois Association for Music Therapy (IAMT) and the Task Force held an Advocacy CMTE and Hill Day in Springfield where over 30 music therapists and students connected with EVERY legislative office, educating about music therapy and asking for support of our bills. Despite a huge gain of supporters and hours of work by the music therapy community, our bills had significant opposition from the Department of Finance and Professional Regulations (DFPR). The department stated that Illinois is currently trying to de-regulate professions and the state is not licensing any new professions, especially those with small numbers like music therapy. The cost for a license would be astronomical. The DFPR was not willing at this time to come to an agreement and work with cost effective solutions proposed by CBMT/AMTA. Senator Kotowski and task force members had several (sometimes heated) calls with the DFPR to see what could be done to help our profession move forward and receive some type of state recognition. Since licensure is currently off the table for this legislative session, Kotowski's office has recommended creating an official Music Therapy Act that would recognize the profession of music therapy in state language. This act would contain AMTA's official definition of music therapy and language from CBMT of who is qualified to practice music therapy. Senator Kotowski believes this Act will be a good first step towards licensure in the future. The spring newsletter for IAMT included tips from Task Force Chair, Nancy Swanson, on how to respond to instances where music therapy is misrepresented. Music therapists were provided with language to use when confronting individuals and providing education on the profession.

Government Relations Report (continued)

Indiana:

The Indiana State Task Force has been following HB 1303, Registry of Certified Professions. This bill establishes a procedure for individuals and existing licensing boards to apply to the professional licensing agency to allow qualified individuals to become state certified and be placed on the electronic registry of professions. Prohibits an individual who are not state certified from using the title "state certified". AIMT have been testifying in favor of this bill and advocating for specific music therapy language to be included. This bill has recently passed out of committee and is eligible for a second and third reading. AIMT Past President Lindsey Wright will be testifying again for this bill on April 9.

Ohio:

The Task Force continues to work with legislators and have a bill drafted for licensure. They are holding a series of Question and Answer sessions around the state for Ohio Music Therapists related to the proposed bill and the process moving forward. OAMT held an Advocacy Challenge in which 146 MTs participated. A Hill Day was held March 18th with 20+ music therapists meeting with over 50 legislators. The day ended with 13 co-sponsors for our bill. AOMT recently redesigned and printed Advocacy materials including brochures and a display banner for use at Hill Days and various events

Michigan:

MMT held an advocacy training on Saturday, March 21, 2015 at the Franciscan Life Process Center in Grand Rapids, MI. There were 32 attendees, including 17 professionals and 15 students. Members of the state task force presented and we also welcomed Jeff Snyder, who is on staff for one of the Grand Rapids-area representatives. In addition, they are busy preparing for a Hill Day at the Capitol in Lansing on Wednesday, April 22, 2015. They will be seeking support and guidance regarding the best course of action for pursuing state recognition of music therapy in Michigan.

Minnesota:

This year, the state task force has been working with the newly elected congress in drafting new language for the Minnesota music therapy licensure bill. With the election, the bill that was heard last year in senate committees are nullified and the process begins again with new bills, bill authors, and hearing deadlines. Final language is close to being drafted to best reflect what was learned last year about specific legal language, to address concerns brought forth from other professions, to most accurately represent the profession, and, most importantly, best protect clients.

Government Relations Report (continued)

Through this process the task force also had to find new authors for our bills. Rep. Dorholt was not re-elected so Rep. Jennifer Schultz has agreed to author our bill in the House. Although Sen. Rosen is still a great supporter of music therapy, she thought it would be more politically appropriate to have a new author on the senate side. Sen. John Hoffmann, who authored last year's bill to add music therapists to the teacher bargaining unit, has taken up licensure for us in the senate.

MTAM is excited to have these bills be introduced this year and plan to push for committee hearings during next year's session They are recognizing several senators and representatives of friends of MTAM at the Friday award luncheon.

Wisconsin:

An email was sent to current WCMT members to inform them of some of the proposed major changes to Long-Term Support such as IRIS and Family Care. Governor Scott Walker's budget proposal would cut IRIS, a long-term care option for people with disabilities and the elderly, and change how Family Care is implemented. These programs would no longer be a part of the Department of Health, but rather fall under the Office of the Commissioner of Insurance. This implementation would change the focus from being quality of life/self-directed model to a more medical necessity model. This change could lead to a great impact on the opportunities of consumers accessing music therapy services.

The committee continues to educate membership regarding the evaluation of appropriate and inappropriate representations of music therapy.

Efforts include:

Collaboration with the National Office of the American Music Therapy Association in publishing the document How AMTA and Music Therapy Relate to the Documentary Film "Alive Inside" and the Organization "Music & Memory" Participation with the Music & Memory panel discussion at the national conference in November 2014

On-going work with AMTA to produce quality informational materials intended to educate the membership about how to answer questions about Music & Memory, and how MT's can work collaboratively with Music and & Memory Programs.

In addition, the committee created a series of podcasts with Cathy Knoll, which will be available to members regarding frequently asked questions to the committee. Standards of Practice Report

- A. The Committee Members have communicated with AMTA members throughout the year about any concerns or suggestions for the AMTA Standards of Clinical Practice. The committee chairs will present this feedback to the Committee at the November meetings. The Committee will address this feedback.
 - a. Discussed email sent by a hospice music therapist just prior to conference. Determined this should be tabled until the new Scope document has been voted on and general standards for assessment are reviewed as a committee as some of the music therapists questions concerned assessment. Melanie will send an email reply to the MT and inform her that this will be reviewed and site our review of NICU specifications in the past and propose that the committee first take this approach with Hospice as well. Committee did raise the absence of 'spirituality' as a domain again (prior years discussions) and determined this may fall under psychological and social domains.
 - b. No other 'feedback' was received by the co-chairs or regional representatives.
- B. The Committee is in the process of reviewing the Standards of Clinical Practice one section at a time. This year, the Committee will be examining the Assessment Section and will make any necessary suggested language changes with the Assembly of Delegates.
 - a. Assessment section was begun and the committee determined the domains were limiting. Discussion was had on its 'general' function and its alignment with the newly crafted Scope materials. The committee moved to table further review until the Scope document vote that is occurring after the committees scheduled meeting time. No changes will be brought to the Assembly this year. The committee has agreed to revisit this mid-year.
- C. The Committee will review the new Scope of Practice, if ready and available, and discuss any conceptual modifications or changes in language that are needed to keep the Standards of Clinical Practice in line with the Scope of Practice.
 - a. The committee moved to table given the pending vote. Will revisit mid-year.
