President Elect's Report

The responsibilities of the President Elect include acting as chairperson of the Awards Committee, reviewing the Bylaws and proposing revisions as needed, and receiving and reviewing applications for Special Projects.

<u>Awards</u> – Each year the GLR presents the GLR presents the following awards; Honorary Life for long time dedication to the field of music therapy, Scholarly Activity for significant contributions to the knowledge base of the profession, and Service for outstanding service to the region. All three awards will be presented during the 2016 awards ceremony, with recipients and their guests will be in attendance. Thank you to everyone who submitted nominations and to the state representatives for responding to the vote

Bylaws

Article V Officers

Section 5. The appointive officers of the GLR shall be an Archivist, Editor, Student Coordinator, and **Website Coordinator**.

Rationale: The website coordinator is appointed by the President, with the approval of the Executive Committee, in the same manner as the other listed appointive officers in this section.

Section 7. Duties

1. The **Website Coordinator** will manage and maintain the GLR website, respond to correspondence that comes in via the website, maintain a list of email addresses for the GLR membership, present reports to the GLR at the Spring and Fall meetings and in the *Voice of the Lakes*, and assist with Special Projects as requested by the GLR Executive Committee.

Rationale: The website coordinator duties are currently not listed in the bylaws. This addition rectifies that omission. The remaining item in this section will be re-lettered.

Article VII – Committees

Section 1. Executive Committee

a. The Executive Committee will consist of thirteen voting members: President, President-Elect, Immediate Past President, Vice President, Vice President-Elect, Recording Secretary, Treasurer, and the six State Representatives. The Archivist, Editor, Student Coordinator, Student Representative, and **Website Coordinator** will be ex-officio members without the right to vote.

President Elect's Report (continued)

Rationale: Adds Website Coordinator to the list of appointive, ex officio members on the Executive Committee, which aligns with the change proposed in Article V, Section 5. Section 11: Annual dues shall be 15 dollars for professional members, 15 dollars for associate members, 7.50 dollars for retired professional members, and 7.50 dollars for student members, payable through the AMTA National Office.

Suggested change Section 11. Annuals dues are set, collected, and received from AMTA.

Rationale: The current language is outdated. The portion of dues received is a percentage that is approved by the AMTA Assembly of Delegates. This language allows for future percentage changes that may be approved by the Assembly and is consistent with AMTA Policy.

<u>Special Projects</u> – We have two types of Special Projects: the MUSE Fund (Musical instruments and supporting materials, clinical Services and Education) and the Research Fund. Application and descriptions of the funds are on the website and included at the end of this newsletter (Pages 42-44).

At the 2015 AMTA conference, one Research Fund was awarded to Jennifer Jones and a MUSE Fund was awarded to Kellee Coviak Hansen. Special projects award recipients are asked to share the results of their projects. At this conference, 2015 spring MUSE fund recipients Carolyn Koebel and Denise Travis will share a one-hour concurrent session and give updates about their projects (More Voices from Hospice Music Therapy, a hospice music therapy recording project and "The Sandbox," a developmental-based program for children up to six years old with diagnoses on the autism spectrum). Jennifer Jones will also share preliminary research findings of Sketches of Music Therapy with Adults with Intellectual Disabilities.

We have one MUSE application to review. Proposals are in a folder in Dropbox for the Executive Board to review. A brief summary is included at the end of this report.

Financials:

I AMT Is currently in good financial standing and our accounts are balanced with our bank account at \$7,799.95 and PayPal at \$5,702.19.

Programming and Continuing Education:

Plans are underway for IAMT's Spring CMTE event to be held on Saturday, June 4th at the University of St. Francis in Joliet, IL. The event will include a training on guitar and relaxation techniques by Louise Dimicelli-Mitran, MA, MT-BC, LCPC, FAMI. IAMT Executive Board will keep the music therapists of Illinois and beyond updated via email and social media as details are finalized and for registration information.

Government Relations/State Recognition Task Force:

Since the passing of SB1595- the Music Therapy Advisory Board, the Illinois Department of Financial and Professional Regulations has conducted interviews with potential members for this board. Final selections will be made and announced on April 13, 2016. The board consists of the following individuals: Andrea Crimmins, Ph.D., MT-BC, Louise Dimicelli-Mitran, LCPC, MT-BC, Kyle Fleming, MT-BC, Candi Gray, LCSW, Russell Hilliard, Ph.D., MT-BC, and Jay Stewart. The board is charged with the task of compiling a report regarding the profession of music therapy. There may be times when professionals within the music therapy community and other professions will be called to testify on certain topics during the board meetings. Nancy Swanson will communicate to the Illinois membership if help is required for this purpose.

Public Relations:

IAMT was successfully represented by Katie Fitch at the Illinois Music Educators Association (ILMEA) Conference in Peoria, IL from January 27th-30th. There were many inquiries about resources for students and information about how to help Illinois students prepare for a career

in music therapy. Allyson Greenenwald was recently appointed to this position, and is looking forward to exploring other events that IAMT can become a part of, as well as continuing to maintain the social media websites.

Clinical Training:

Currently, we have 11 approved internship sites in the state of Illinois: 7 are active internship sites and 4 are inactive.

Illinois State Report (continued)

Data continues to be analyzed for the feedback gathered from the internship survey. This survey has provided us with information regarding concerns, areas of improvement, and areas that are going well with Illinois music therapy sites. Music therapists have also raised some concerns regarding the AMTA process to approve an internship. Moving forward the executive board wishes to create a small committee of people to address the concerns that were brought to light in the survey. It would be most beneficial to have the following people represented: internship director, someone in the process of applying to be an internship director, and a professor.

Website:

Over the next months, IAMT Website Coordinator Stephanie Solomon will be researching and gathering information about overhauling the website. The plan is to gather information by Labor Day and develop a plan on future steps with updating the website.

Student Affairs:

The student retreat was held at Illinois State University on Saturday, February 20th and went well. There were 19 students in attendance. Allison Gunnink, MBA, MT-BC and Meryl Brown, MM, MT-BC presented on professionalism, résumé techniques, etiquette and session planning. The student scholarship was announced at the retreat, but unfortunately no applications were received. IAMT Student Coordinator Mia Meacher will be communicating with the students and new student presidents to continue to work on this issue for upcoming years.

Past President:

IAMT Past President Jenni Rook has found an accountant who will review and advise us on how to complete our 501(c)(3) application for only \$100. The hope is to have board approval of the application over the summer, if not sooner. We will be granting two IAMT Recognition Awards at the Illinois State Meeting during the GLR conference. One IAMT member will be recognized for outstanding service, and an Occupational Therapist will be acknowledged for her contributions to the field of music therapy.

Other Business:

The IAMT Executive Board consists of multiple new members. The board is looking forward to continuing to grow opportunities for the music therapists in Illinois, as well as the residents.

Indiana State Report

We were excited to host the GLR Conference this year! Many of our board members assisted with the planning process. Thanks to all volunteers!

Membership

The Association for Indiana Music Therapy currently has 63 members, including 4 students and 2 retired members. As of 4/10/2016, we have \$4,585.62 in our account. Non-profit paperwork has been filed for 2015.

Past Meetings

The Fall Meeting was held September 12 at IUPUI and featured a presentation by Jan Schreibman titled, 'Ethical Considerations in Delivery of Compassionate Care,' a networking lunch, business meeting, and GLR conference committee planning time. During the business meeting, bylaw revisions were presented by Past President Lindsey Wright. A vote was sent out to the membership via Survey Monkey and all bylaw revisions were approved. No meeting was held this spring as Indiana is hosting the GLR conference.

Clinical Training/ Internships

The 2016 AIMT Internship Scholarship is being awarded to Laura Russell who is an intern with Lindsey Wright at Opportunities for Positive Growth.

Indiana currently has six active national roster internship sites: Riley Hospital for Children at Indiana University Health, Bi-County Services, Opportunities for Positive Growth, Meaningful Day Services, Season's Hospice, and State of the Heart Hospice. In addition, our state has five institutions educating future music therapists: Saint Mary of the Woods College, Indiana University Purdue University-Indianapolis, Indiana University Purdue University-Fort Wayne, University of Evansville, and, Indiana Wesleyan University. See below for detailed reports from each internship:

Riley Hospital for Children at Indiana University Health– Ann Hannan - We had one intern from KU complete his university affiliated internship in March, John Robinson. We are on hold again since we are down two music therapists right now.

Bi-County Services– Karel Decker, Internship Director –Beth Allard from St. Mary-of-the-Woods College started in January and will continue until July. Wen Chi Chiu from Illinois will begin her internship in July.

Opportunities for Positive Growth – Lindsey Wright, Internship Director - We currently have Laura Russell as our Intern through June 2016. JD Hogue finished his internship in December. We will be looking to fill two internship positions in the summer in Fishers as well as Kokomo.

Meaningful Day Services – Leigh Ann Fuller, Internship Director – Maprang Fakto completed her internship in March at our Jeffersonville location. We will not be offering our internship spot for the time being until another intern supervisor has been trained at this site.

January 2016 Pin-Hue Huang and Jinyun Jung will begin their internship and complete them in July 2016. Internships have been offered and accepted for our June 2016 internship spots in Kokomo by Hannah Becker and Ft. Wayne by Jessica Barcus. Indianapolis interns will begin in July 2016 for Patricia Walke and Alex Dickerson.

Indiana State Report (continued)

State of the Heart Hospice – Amy Pearson, Internship Director - State of the Heart Hospice currently has a new intern, Kristina Simer from Slippery Rock University started her 6 month internship in January. We have an internship opening for the summer of 2016.

Season's Hospice – We provided internships to two MT interns in 2015. During 2016, we have 2 students who started their MT internships in January at our IN site.

University Affiliated

Evansville University – **Mary Ellen Wylie** - We have 3 University of Evansville students in internships in Texas or Florida. Other students are in the process of applying. We do not have any students completing a University Affiliated Internship right now, but we are planning to create one for the fall.

In order for our student to do an internship in Texas, I had to apply for authorization from the state. You might share with others that the application process was not that difficult, but I could not proceed with creating a formal Affiliation Agreement or the Individual Clinical Training Plan until I received the Certificate of Authorization from the Texas Higher Education Coordinating Board.

St Mary of the Woods – Sharon Boyle - A student completed her national roster internship at Southbury Training School in CT. Another student started an internship at Bi-County Services in Indiana in January.

IPFW – Peggy Farlow and Nancy Jackson – Interns currently at: Lurie Children's Hospital in Chicago, VA Northern IN Healthcare System in Marion (university-based internship). Students starting internships in the next 6 months at Park Nicollet Hospital in Minneapolis, Meaningful Day Services, Lurie Children's Hospital in Chicago, VA Northern IN Healthcare System in Marion (university-based internship). We also expect that we will have a student in a university-based internship at Lutheran Hospital in Fort Wayne sometime this year, but these plans are still in development.

Public Relations

AIMT hosted a social event on October 25th at Garfield Park in Indianapolis. The event was well-attended with Indiana MT-BC's and their families enjoying a small cookout and socializing.

State Task Force

HB 1303, Registry of Certified Professions, a bill that the Indiana State Task Force followed closely during the 2014-2015 legislative session, passed. This bill establishes a procedure for individuals and existing licensing boards to apply to the professional licensing agency to allow qualified individuals to become state certified and be placed on the electronic registry of professions. It prohibits an individual who is not state certified from using the title "state certified". Lindsey Wright, past president and government relations chair, has been in contact with the Indiana Professional Licensing Agency to add Music Therapy to the new self-registry pilot program. She will be meeting with the Director at the end of April to clarify the path forward.

Membership

Current membership of the Music Therapy Association of Minnesota (MTAM) currently stands at 51 (45 professionals and 6 students) and is expected to rise as music therapists register for our upcoming state conference. Our Public Relations chair, Jennifer Hicks, has made a concerted effort to encourage MT-BCs to join earlier in the year to reap membership benefits earlier, such as job postings and scholarship opportunities.

Financials

MTAM, a 501(c)3 organization, is in good financial standing with a total of \$9,744.38 in liquid assets. This summer, our board will secure our organization's future and provide stability by creating a more transparent budget, with expense categories based on our mission statement detailing how our resources are spent.

Board

STATE REPORTS

Illinois:

Since the passing of SB1595 – the Music Therapy Advisory Board, the Illinois Department of Financial and Professional Regulations has conducted interviews with potential members for this board. Final selections will be made and announced on April 13, 2016. The board consists of the following individuals: Andrea Crimmins, Ph.D., MT-BC, Louise Dimicelli-Mitran, LCPC, MT-BC, Kyle Fleming, MT-BC, Candi Gray, LCSW, Russell Hilliard, Ph.D., MT-BC, and Jay Stewart. The board is charged with the task of compiling a report regarding the profession of music therapy. There may be times when professionals within the music therapy community and other professions will be called to testify on certain topics during the board meetings. Nancy Swanson will communicate to the Illinois membership when help is required for this purpose.

Indiana:

The Indiana State Task Force reports HB 1303, Registry of Certified Professions, passed. This bill establishes a procedure for individuals and existing licensing boards to apply to the professional licensing agency to allow qualified individuals to become state certified and be placed on the electronic registry of professions. It prohibits an individual who is not state certified from using the title "state certified". Lindsey Wright, IAMT Past President and Government Relations Chair, has been in contact with the Indiana Professional Licensing Agency to add Music Therapy to the new self-registry pilot program. She will be meeting with the Director at the end of April to clarify the path forward.

Michigan:

Ohio:

Ohio HB 184 is scheduled for a hearing in the Commerce and Labor Committee on Tuesday, April 19th. AOMT members are encouraged to attend. Updates will continue to be posted regularly on the AOMT Facebook page and periodically through email.

Wisconsin:

An email was sent to current WCMT members to inform them of some of the proposed major changes to Long-Term Support such as IRIS and Family Care. Governor Scott Walker's budget proposal would cut IRIS, a long-term care option for people with disabilities and the elderly, and change how Family Care is implemented. These programs would no longer be a part of the Department of Health, but rather fall under the Office of the Commissioner of Insurance. This implementation would change the focus from being quality of life/self-directed model to a more medical necessity model. This change could lead to a great impact on the opportunities of consumers accessing music therapy services.

RECAP of National Items from the 2015 Conference in Kansas City:

- 1. Congratulations to the Oregon Task Force for their advocacy in obtaining music therapy state recognition. Successful legislation created a music therapy license for board certified music therapists granted by Oregon's Health Licensing Office (HLO).
- 2. Congratulations as well to the Illinois Task Force for their advocacy that contributed to the passage of a licensure study within the state.
- 3. The California Task Force worked diligently to have a title protection bill pass the Assembly and Senate unanimously. Unfortunately, the Governor vetoed the bill, but the veto message did support recognition of the MT-BC credential and CBMT certification requirements.

Government Relations Report (continued)

- 4. This year marks the 10 year anniversary of the AMTA and CBMT state recognition operational plan. In 2015, 16 states hosted Hill Days, 14 states introduced legislation, and 43 states have Task Forces involved in advocacy at various levels. As of November 2015, we are anticipating recognition legislation in at least nine states in 2016.
- 5. MTR 2025 included a presentation that focused on the impact of research on policy. There was also a conference concurrent session offered that included the recommendations related to research and policy.
- 6. AMTA has received updated support from the federal Department of Education regarding music therapy as a related service under the Individuals with Disabilities Education Act (IDEA). The Office of Special Education Programs (OSEP) issued guidance to all state special education directors clarifying the Department's previous communications recognizing music therapy as a related service. Supportive language is being prepared for posting on the AMTA website as a resource for members and families.
- 7. Arts Advocacy Day will be held March 8th and 9th, 2016. We would like for a strong music therapy contingent to be in attendance and will be sharing registration information with the membership when it becomes available.
- 8. Plans for 2016:
 - Increase social media posts of AMTA advocacy work on the state and federal level
 - Prepare a "Civics for Music Therapists" or "Policy 101" podcast/video for members
 - Offer advocacy training opportunities to music therapy educational programs within each region.

Professional Advocacy Committee Report Jessica De Villers

The In February 2016, Jessica De Villers is appointed Professional Advocacy Representative for the Great Lakes Region of AMTA. Leslie Henry and Jessica De Villers are working together in the transition process.

The PAC committee continues to educate membership regarding the evaluation of appropriate and inappropriate representations of music therapy.

Efforts include:

- The executive board has charged the committee with initiating a decision tree infographic that can help promote work flow when cases of misrepresentation occur. The current challenge is that a clear communication does not exist between PAC, National Office, and states that have task forces and recognition, this causes confusion of who to report issues to. The goal is to improve communication between the groups working to clearly represent music therapy to the public and protect its use.
- We continue to assist and monitor member's responses to advocacy issues.
- The committee manages and maintains a resource file of responses and have created a new committee google doc to store committee documents.

General Business Meeting Minutes

Indianapolis, IN

Friday, April 15 and Saturday, April 16, 2016

I. Call to order

Larisa McHugh welcomed everyone and called the meeting to order at 5:05 pm with a special musical event from the GLR AMTAS Students.

II. Approval of agenda

The agenda was presented. A motion to approve the agenda was received and seconded. All were in favor. The agenda was approved.

III. Approval of minutes from Kansas City, Missouri (November 2015)

Minutes were reviewed. A motion to accept the minutes was received and seconded. All were in favor. The minutes were approved.

IV. AMTA President's Update Jennifer Geiger

Jennifer will be giving a big update tomorrow. Please welcome her.

V. Elected Officer Reports:

a. President: Larisa McHugh

Larisa shared that her role is to continue the focus on strategic planning and to continue to hold conference calls with the executive board. She stated that the board has moved forward with the mentor program and it has since gone live. More information will be presented on this later in the meeting. A few goals Larisa has for the term are to focus on strategic planning and to assist in streamlining conference planning. This was a big part of the executive board meeting yesterday.

Larisa shared that, over the last several years, we've been fortunate to be in very healthy financial standing as a region. We have made great efforts to return that to our members. Members have seen this through awards, through low conference rates. Our conference rates for regional conference are the lowest out of all AMTA regions. The GLR has been able to donate to the AMTA archives and has supported AMTA conference events. Our financial health is a result of successful conferences each year and of the fiscal responsibility of the board. Our current co-chairs need to be commended for the fine job they have done with this conference. Our total conference attendance has ranged from 300-400 and this year we have 504 before the conference started. In 2014 when the contract was signed for this hotel we believed it would be one of the largest conferences ever. Unfortunately the contract had a few difficult elements which were recently discovered and which we haven't been able to absorb. The room block was more than double what we normally have. This was a very large hurdle. Additionally, as a way to not pay 50,000 for room usage for meetings, we were required to pay \$40,000 for catering. The board and co-chairs have been working to find creative ways to whittle down these costs. Larisa shared that the cochairs, VP, VP elect, and executive board have met several times to discuss these issues. AMTA has been involved and offered assistance, attempting to renegotiate the contract with the hotel but were unable to do that. We've worked to increase attendance through increased emails, through multiple extensions of conference early bird rates, and promoting through social media. We considered offering free CMTEs and other incentives to increase attendance. Larisa shared that, despite great attendance and good effort, we are still facing a large deficit in regards to this conference. Moving forward, all contracts will be reviewed by the GLR executive board as well as by AMTA conference planners. The board has established conference policies so all conference planners have clear expectations and that planning processes are streamlined so as to avoid problems like this in the future. More will be explained about this in later portions of this meeting. If anyone has any questions, please ask or contact Larisa. We are happy to answer any questions you may have.

b. Past President: Lisa Gallagher

Lisa was unable to attend this conference. Larisa will be presenting Lisa's report on her behalf.

As past president Lisa serves as chair of the nominating committee. She presented a list of nominees for the nominated positions:

President Elect – Rebecca Findley (IN) Vice Pres Elect – Jennifer Whitlow (IN) Todd Schwartzberg (MN) Secretary – Lindsey Doty (OH) Treasurer – Stephanie Harris (IN)

If you have questions about any positions please seek out Larisa. Nominations from the floor are welcome tomorrow. From there emails will be sent to all members so you will have the bios to read and you will be able to make a vote via Survey Monkey.

c. President Elect: Debbie Bates

Debbie shared that she will be giving three awards at the luncheon tomorrow. All honorees are here.

We do have Special Projects funds available. Yesterday the board did approve one MUSE/Special Project fund and it was awarded to Lee Anna Rasar.

Bylaws Revisions - Debbie presented bylaws revisions. The proposed revisions are as follows and will be voted on tomorrow night:

Article V Officers

Section 5. The appointive officers of the GLR shall be an Archivist, Editor, Student Coordinator, and **Website Coordinator**.

Rationale: The website coordinator is appointed by the President, with the approval of the Executive Committee, in the same manner as the other listed appointive officers in this section.

Section 7. Duties

1. The **Website Coordinator** will manage and maintain the GLR website, respond to correspondence that comes in via the website, maintain a list of email addresses for the GLR membership, present reports to the GLR at the Spring and Fall meetings and in the *Voice of the Lakes*, and assist with Special Projects as requested by the GLR Executive Committee.

Rationale: The website coordinator duties are currently not listed in the bylaws. This addition rectifies that omission. The remaining item in this section will be re-lettered.

Article VII – Committees

Section 1. Executive Committee

a. The Executive Committee will consist of thirteen voting members: President, President-Elect, Immediate Past President, Vice President, Vice President-Elect, Recording Secretary, Treasurer, and the six State Representatives. The Archivist, Editor, Student Coordinator, Student Representative, and **Website Coordinator** will be ex-officio members without the right to vote.

Rationale: Adds Website Coordinator to the list of appointive, ex officio members on the Executive Committee, which aligns with the change proposed in Article V, Section 5.

Section 11: Annual dues shall be 15 dollars for professional members, 15 dollars for associate members, 7.50 dollars for retired professional members, and 7.50 dollars for student members, payable through the AMTA National Office.

If anyone has any questions on this, please find Debbie.

d. Vice President: Rebecca Findley

Melaine presented a combined report on behalf of Rebecca and herself.

Melaine invited the current conference co-chairs to give a rundown of numbers and current report on the conference.

Jennifer shared that we had 504 pre-registrants. 301 were professionals. This was the first time in a long time that the number of registered professionals exceeded that of registered students. Since onsite registration opened approximately 15 additional individuals registered. In terms of additional attendance, 85 people will be attending CMTES and about 40 individuals attending institutes.

Anne shared that we received two proclamations related to the conference. The Office of the Mayor has declared April 2016 as Music Therapy Awareness Month. In the State of Indiana the governor has slated this entire week as Music Therapy Awareness Week.

Rebecca shared more insight into the thoughts shared earlier by Larisa. In order to avoid similar financial issues in planning future conferences, she and Melaine have created an intensive Google Drive with templates, schedules, CMTE letters, and contracts for entertainment so that co-chairs have the resources they need to successfully plan a conference. In addition, all policies are being written down and saved in this shared spot.

The 2017 Conference will be held at the Crowne Plaza in Milwaukee, Wisconsin from March 14-18. It is accessible from the airport, available at a rate of \$119 (single/double/triple/quad), and includes free parking and a free airport shuttle.

Promotional materials for the conference were distributed at this time. The theme for the 2017 conference is "Thirst for More: Tap into Your Greatest Potential." The conference will focus on reaching within yourself to access your greatest potential. The conference falls on Saint Patrick's Day. In addition the NCAA will be held in Milwaukee at that time. With this in mind, please plan accordingly when booking your hotel.

The committee chairs for this conference are lined up. Registration rates were shared at this time.

Melaine shared a breakdown on what conference registration includes. Please think about this as you consider the cost of registration.

e. Vice President Elect: Melaine Pohlman

Melaine shared her report in conjunction with Rebecca.

f. Secretary: Lindsey Doty

No report. Please place your minutes in Dropbox.

g. Treasurer: Stephanie Harris

Stephanie presented the fiscal report from July 2015 (FY 15-16).

Stephanie reported she has reactivated the DUNS/SAM number. This is a number that government facilities use to check your eligibility to reimburse for attending a conference. This number was reactivated and Stephanie wants to make sure the membership knows this number exists and is active. AMTA is also considering doing this so, for national conference, you may want to check with them for a number.

CMTE fees need to be sent 4 weeks prior to the event to avoid \$100 in late fees from CBMT. The deadline from CBMT is two weeks prior but, if GLR doesn't have the fee to them by that two week period, GLR gets charged a late fee. Please get your fees in and communicate with Kristen and Stephanie to let them know when to expect fees.

Stephanie recently moved. As a result, all forms have been updated to reflect her new address. Please use the new forms (CMTE and reimbursement forms) rather than the old.

Checking: \$3,632.74 Savings: \$16,991.13 Conference: \$9,272.00 Student: \$865.75 Investment: \$19,215.45 Total Assets: \$49,677.07

There is the potential for more money to be coming back from the hotel, given we had to pay the hotel in full prior to conference. In addition, there may be additional income given on-site registrations.

We lost money in the Morgan Stanley account due to trading. This is reflected in the budget spreadsheets prepared by Stephanie.

Conference checking expenses versus revenue was shared. This is based only off the checking account. This is not a clear picture of this current conference, but also includes continued costs from the conference in Minneapolis.

VI. State Representative Reports:

a. Illinois: Allison Gunnink

The full report is in Dropbox. Allison shared the Illinois state association is at 144 total members. They are in good financial standing. They are finalizing details for their spring CMTE scheduled for June 4 with Louise Dimiceli-Mitran. Allison stated that, last year, Senate Bill 1595 was approved and the advisory board has now been appointed. This board will now be looking at if there is a need for licensure in the state. The association will be researching possibilities of overhauling the website with the intent to have a plan by Labor Day. A student retreat was held in February. They are still working on completing 501(c)(3) application. An accountant in place.

b. Indiana: Morgan Sparks

The full report is in Dropbox. AIMT currently has 63 members, including 4 students and 2 retired members. The organization is in good financial standing. Non-profit paperwork has been filed for 2015. A successful fall meeting was held in September, featuring a presentation on ethical considerations. AIMT has awarded their 2016 internship scholarship. Indiana currently has six active national roster internship sites. House Bill 1303 passed. This bill establishes a procedure for individuals and existing licensing boards to apply to the professional licensing agency to allow qualified individuals to become state certified and be placed on the electronic registry of professions.

c. Michigan: Kellee Coviak- Hansen

Michigan Music Therapists currently has 48 professional, 4 lifetime, and 51 student/intern members. Michigan is home to two active student groups, one at Eastern Michigan University and Western Michigan University. Kellee reported that this past fall they converted the membership form to a Google form which has been very successful. A new executive board will be coming into place on Saturday should they meet quorum. The annual spring workshop is Sunday, May 22. This workshop will focus on reimbursement, scholarship opportunities, and letting membership know about programs available for money (scholarships, special project funds, etc). The workshop is entitled, "More Bang for Your Buck." Members of other state associations within the region are able to attend at member rate. MMT Week is scheduled for the end of April. The 2018 GLR conference will be held in Michigan.

Adjournment of Friday General Business Meeting: A motion was made to adjourn the meeting and was seconded. Larisa adjourned the meeting at 6:09 pm and will recontinue the following evening at 5:00pm.

Welcome and Call to Order: Larisa welcomed those in attendance and called the meeting to order at 5:01pm.

d. Minnesota: Claire Klein

Minnesota has an active task force. Their state association currently has 51 members, comprised of 45 professionals and 6 students. This number is expected to increase with the coming conference in May. The board has started a new practice of having an attitude of gratitude, where each time they meet a card is sent to a member in the music therapy community with a note of encouragement and thanks. Claire reported the board has rewritten their mission statement and this is being voted on in May. Once this part of the bylaws is updated they hope to update the budget to reflect the mission statement. A number of scholarships are available for members. There are currently 5 national roster internships in the state. The board is hoping to focus on how to start an internship at future CMTE sessions (fall conference). A Twitter and Instagram account are now active.

e. Ohio:

House Bill 184 has been sitting in Commerce and Labor since last June, with a tentative hearing scheduled to occur in the next week. This will include opponent testimony and interested party testimony. The AOMT summer CMTE is planned for June 4 in Columbus and will feature Tracy Richardson. The fall CMTE is tentatively scheduled for October 1 and will feature Julie Palmieri. AOMT is working to set up regional networking events and the board is still looking for people to help out with that. The association now has a members-only section that was effective January 1. All job postings and other resources were moved to this area. All professional scholarships have been utilized since they were started last year. In addition, the membership support fund was utilized.

f. Wisconsin: Alexis Graff

Passages happened on 4/14. Several students presented. An advocacy discussion was included, and the keynote speaker was Jenni Rook. 27 students attended. Two grants/scholarships were awarded. Ellen reports they have continued to communicate with schools in the region through social media, working to facilitate increased communication between the schools.

In 2015 he did another presentation at the 22nd International Conference on Learning at the University of San Pablo CEU in Madrid, Spain, co-presenting with Louise Steele and Dean Robert McCallister. His second edition of Biomedical Foundations in Music Therapy is being translated into Spanish by a group in Argentina.

It doesn't mean the regional representative will do all the work, but they will help empower and guide the local therapist through the process of how to advocate appropriately and effectively. The committee aware. The other thing that is important: If your state has licensure or registry, the task force role is to help get legislation moving forward but it is the professional advocacy's role to help be involved and follow up in these cases of misrepresentation. Please remember the PAC committee and the formal process instead of only providing the information of misrepresentation to your state task force. The other things the committee has been charged with: They will be creating a decision tree infographic that will be available. This will be something like a map of the US, so for the

states with licensure or a registry or specific state recognition that is different than the normal procedure, you'll be able to click on the state to figure out the appropriate protocol for your state in terms of dealing with misrepresentation. This will also hopefully help develop even more clear communication between task forces, CBMT, and AMTA. The committee is also working on improving and updating the music modalities information. Special Projects

Special Projects is a mechanism established by the Great Lakes Region for members to support clinical projects, research projects, or committee-related projects. Funding is available in two categories: the MUSE Fund (MUsical Instruments and supporting materials, clinical Services, Education) and the Research Fund. Each fund has a specific purpose, protocol, and eligibility requirements.

The MUSE fund is intended to support the needs of clinicians, the clinical use of music therapy within the CBMT Scope of Practice, AMTA Standards of Clinical Practice, and within the boundaries of the Professional Competencies of music therapists, and the advancement of GLR. Members of the GLR, including student members, can apply for funds to support the clinical use of music therapy including the purchase of musical instruments and supporting materials, the clinical training of the music therapist, clinical services of a music therapist, or one-time committee-related projects. The outcomes of projects supported by the MUSE fund are to be *clinical* or *professional* in nature. Data collection related to projects funded by MUSE is to be for the express purpose of enhancing the quality of music therapy service for the *client* or for advancement of the music therapy *profession* and not intended for research. Should data be collected for the purpose of presentation or publication, applicants should apply for Research funds.

Applicants are encouraged to apply for the MUSE funds to support various aspects clinical practice and professional life as a music therapist. Examples of materials, education, and services include but are not limited to the following items: drums, iPad, Orff instruments, sign language course, fees for a clinical music therapist, parachute, one-time committee travel expenses, etc. Within the application, it should be made clear how the funds would be used and how the practice of music therapy would be enhanced by the funds.

Members interested in conducting music therapy research are encouraged to apply for the Research fund. Projects that are considered to be research are those that collect various types of data for the purpose of answering a research question that may or may not directly impact a specific client. These include master's theses, dissertations, and other studies where publication or presentation is the desired format for distributing results. All applicants proposing research involving human participants must have clearance by to an Institutional Review Board (IRB) or Human Subjects Review Board (HSRB). The GLR Executive Board will consider only those research proposals that have such a mechanism in place for protection of human participants. Research that is approved by the GLR Executive Board will receive funding only after the applicant/researcher provides written proof of IRB/HSRB approval.

Research funding can be used to cover expenses related to research including but not limited to the following areas: travel costs, materials, testing measures, computer time, analysis support, instruments, clinical services for another music therapist, etc. Stipends for the primary researcher are not the purpose of this fund, but will be considered in conjunction with other expenses and funding sources.

Applications for either fund are due to the President Elect 30 days before the conference (GLR or AMTA) during which they will be considered. One project can be funded at the annual AMTA Conference, and one project may be funded at the GLR Regional Conference. If no project is funded at the AMTA Conference, then, two projects may be funded at the GLR regional conference. Each project, regardless of the type, that is approved by the Executive Committee will be funded at an amount up to \$1,500.

SUBMISSION PROCESS:

- 1. Complete Special Projects Fund Application *(on the next page)* and use it as a guide in creating your proposal.
- 2. **Submit completed cover letter with your full proposal.** Submit to the GLR President-Elect at least 30 days before a GLR or AMTA conference.
- 3. **Submit a** *separate document* **for blind review.** In this copy, please do NOT include the cover letter. Also, please remove any identifying information (name of music therapists, facility name, city, etc.) from the proposal. Submit to the GLR President Elect at least 30 days before a GLR or AMTA conference. This is the copy that will be shared with the GLR Executive Board members; discussion and voting will take place during the GLR Executive Board meeting at the next conference (GLR or AMTA).
- 4. Applicants will be notified within 30 days after a GLR or AMTA conference regarding the GLR Executive Board's decision.

DEADLINE FOR APPLICATIONS: 30 days before GLR or AMTA conference.

Special Projects Fund Application

Special Projects is a mechanism by the Great Lakes Region for members to support clinical projects, research projects or committeerelated projects. Funding has been used to cover some expenses related to travel costs, materials, testing measures, or computer time. Funding is typically not approved for stipends. Funding is available in two categories: the MUSE Fund (Musical Instruments and supporting materials, clinical Services, Education) and the Research Fund. Each fund has a specific purpose, protocol, and eligibility requirements. Persons interested in any type of research or conducting a project directly related to clinical practice are encouraged to apply.
