At the Awards Luncheon, we also recognized the Michigan music therapy internship sites and directors, including: Franciscan Life Process Center (Miranda Eden), Keiden Center (Susan Gregory), Lighthouse Neurologic Rehabilitation Center (Janelle Warren), Kalamazoo Psychiatric Center (Mary Kruger), and Seasons Hospice and Palliative Care (Russell Hilliard). Thank you for all you do to help develop the next generation of music therapists!

Strategic Planning: The GLR Executive Committee met Thursday morning of conference to continue our Strategic Planning process. We were fortunate to once again have Bill Hogan as our guide. We discussed the things we have accomplished over the past year, including two major surveys (one on the topic of mentoring, and one that targeted the needs of students). We learned quite a bit from the survey respondents. For example, on the student survey 93% of respondents stated they are happy with the services provided by GLR. On the other hand, many students did not know that membership in GLR was an option for students. So, we obviously have work to do! Watch the GLR website for more complete summaries of those surveys. Thank you to Dr. Terra Merrill (mentoring survey) and Melaine Pohlman (student survey) who spearheaded the creation and distribution of those surveys, as well as to all the GLR members who have been helping with strategic planning tasks. We hope to post summarized results of those surveys on our website soon.

We set forth two main goals for our Strategic Planning Process for the next year: 1) improve communication and 2) identify potential new products and services. We divided the Executive Committee into two "teams," with one team in charge of each goal.

ETAB Town Hall Meeting: Two members of the ETAB (Education and Training Advisory Board) of AMTA, Jim Borling and Bridget Doak, joined us for a Town Hall meeting at the recent GLR conference. In addition, Ronna Kaplan and Amy Furman participated as representatives of AMTA. In this 60 minute meeting, several GLR members came to the microphones to share their thoughts and opinions regarding the potential move to a master's level entry. I want to thank everyone who shared their opinions; you all did so in a respectful and professional manner. We audio recorded the session, and had two note-takers. After conference, I sent those recordings and notes to AMTA, where they were considered (along with those from the other regions) at the mid-year Board Meeting. At this time, we have been notified that the Assembly will not vote on this issue in 2012; rather, more time will be taken to discuss and gather facts.

Other accomplishments:

- 1. GLR now has a Survey Monkey account.
- 2. We are now using Dropbox, a secure site in which we can store GLR reports and other documents. All members of the Executive Committee can view those documents from any computer or mobile device. In addition, this allows us to operate in a more "green" fashion.
- 3. GLR members voted to add the position of Vice President Elect to our Executive Committee.
- 4. The Executive Committee voted to increase funding for the GLR student group (GLR-AMTAS), which will help them with the costs of the Passages conference they do each year prior to the GLR conference.
- 5. We have recently filled two positions on AMTA committees: Nancy Dexter-Schabow is the GLR representative to the Reimbursement Committee and Peter Meyer is the GLR representative to the Standards of Practice Committee.

It has been an exciting time to be the President-Elect of GLR. At the GLR conference in Grand Rapids I was shared an update on the three major duties of my position, and I share those with you here.

My first duty is to review the Bylaws and suggest any necessary changes. In Grand Rapids I presented two significant changes to the Bylaws, and they were both approved by the Membership. These two things were to add a Vice President-Elect position and to provide official recognition of the GLR-AMTAS. Within this edition of the VOL you will find a copy of our newly revised Bylaws. There are several other items that AMTA has asked us to consider including in our Bylaws, so I will look at them and present any other needed changes at the 2012 AMTA conference in St. Charles, IL.

It is also within my job description to oversee Special Projects. We have revised the process for applying for Special Projects. Funding is now available in two separate categories, with each fund having its own specific purpose, protocol, and eligibility requirements. The two categories are: 1) MUSE Fund – **Mu**sical instruments and supporting materials, clinical Services, Education; and 2) Research Fund. Workforce Development and Retention Committee Cindy Ropp

The Workforce Development and Retention Committee (formerly known as Employment and Public Relations) was given a new title and charge from the AMTA Board. At the annual conference, we worked at developing an online resource for prospective employers that will hopefully soon be found on the AMTA website. Look for it!

We discussed developing a list of presentation mentors. Public presentations about music therapy are happening all the time. For persons new to the profession, having a mentor to help walk through the process of presentation development can be helpful. We will be talking with regional conferences about ways to identify those who would be interested in serving as mentors.

The committee is exploring career databases that are frequently accessed by high school students and those who are considering a career change. The intent of this initiative is to identify databases which do not have any accurate information about the music therapy profession, and provide them with updated helpful information and resources.

The committee is suggesting that regional associations consider including a high school student information session at each regional conference. Local guidance counselors could be contacted to identify potential interested students and the regional conference could program a session for these students as an outreach endeavor.

Finally, the committee is exploring ways to encourage local music therapists to set up a booth about music therapy at a related conference (for example, conferences for music educators or guidance counselors). We are suggesting that regional and state association's dialogue about what resources, financial and material, might be available to assist in such endeavors. It would be a great way to reach out to professionals who come in contact with prospective music therapy students!

Research Committee Report Deb Burns

The goals of the AMTA Research Committee are to encourage and promote research of all types of research methodology in music therapy and to take complete responsibility for the research sessions at national conference. A few years ago, the AMTA Executive Board charged two specific tasks to the research committee: 1) Investigate specific ways to educate the profession regarding current music therapy research, and 2) Identify those areas of practice lacking supportive research documentation.

AMTA National Conference Research Presentations and Poster Session

The Research Committee will be sponsoring four "State of the Science" presentations at National conference this October. These panel presentations bring together clinicians and researchers to discuss the current evidence from multiple perspectives related to specific content areas: Pain management, Autism, Trauma, and Technology.

Research Poster Proposal submissions are due June 29, 2012 by 5 pm Eastern time. The call for Research Poster proposals is available online:

Additional Notes:

In order to determine additional educational needs of our membership, the committee is, with Eric Waldon's leadership, developing a survey study exploring current music therapists perspectives about research, perceived benefits to participating and being a good consumer of research findings, and perceived barriers of the same. He has started a literature review and has found standardized measures from nursing and occupational therapy that will be modified to be specific to music therapy. We will also, probably, follow up with qualitative interviews so that we may create a broad theory about professional participation in research, including but not limited to: reading and implementing findings into clinical practice, providing clinical services within a research study, and being a study investigator.

Clinician-Based Research Award

The committee and AMTA will release the call for proposals for the Clinician Research award. Details about submission requirements will be on the AMTA website. The award will be a maximum of \$5,000 and proposals will be due November 12.

Special Projects – GLR of AMTA

Special Projects is a mechanism established by the Great Lakes Region in order to support members' clinical projects, research projects, or committee-related projects. Funding is available in two categories, with each fund having its own specific purpose, protocol, and eligibility requirements. The two categories are the:

- 1) MUSE Fund MUsical Instruments and supporting materials, clinical
- Services, Education
- 2) Research Fund.

The MUSE Fund is intended to support the needs of clinicians, the clinical use of music therapy within the CBMT Scope of Practice, the AMTA Standards of Clinical Practice, the Professional Competencies of music therapists, and the advancement of GLR. Members of the GLR, including student members, can apply for funds to support the clinical use of music therapy. This includes the purchase of musical instruments and supporting materials, the clinical training of the music therapist, clinical services of a music therapist, or one-time committee-related projects. The outcomes of projects supported by the MUSE Fund are to be *clinical* or *professional* in nature. Data collection related to projects funded by MUSE is to be for the express purpose of enhancing the quality of music therapy services for the *client* or for the advancement of the music therapy *profession*. This fund is not intended for research. Should data be collected for the purpose of presentation or publication, applicants should apply for the Research Fund.

Applicants are encouraged to apply for the MUSE Fund to support various aspects of clinical practice and professional life as a music therapist. Examples of materials, education, and services include, but are not limited to, the following items: drums, an iPad, Orff instruments, a sign language course, fees for a clinical music therapist, a parachute, one-time committee travel expenses, etc. Within the application, it should be made clear how the funds would be used and how the practice of music therapy would be enhanced by the funds.

Special Project Information Lisa Gallagher

Members interested in conducting music therapy research are encouraged to apply for the Research Fund. Projects that are considered to be research are those that collect various types of data for the purpose of answering a research question that may or may not directly impact a specific client. These include master's theses, dissertations, and other studies where publication or presentation is the desired format for distributing results. All applicants proposing research involving human participants must have clearance from an Institutional Review Board (IRB) or Human Subjects Review Board (HSRB). The GLR Executive Board will consider only those research proposals that have such a mechanism in place for protection of human participants. Research that is approved by the GLR Executive Board will receive funding only after the applicant/researcher provides written proof of IRB/HSRB approval.

Research Fund monies can be used to cover expenses related to research including, but not limited to, the following areas: travel costs, materials, testing measures, computer time, analysis support, instruments, clinical services for another music therapist, etc. Stipends for the primary researcher are not the purpose of this fund, but they will be considered in conjunction with other expenses and funding sources.

Applications for either fund are due to the President-Elect 30 days before the conference (GLR or AMTA) during which they will be considered. One project in each category (MUSE and Research) may be funded at the annual AMTA Conference, and one project in each category may be funded at the GLR Regional Conference. If no project is funded at the AMTA Conference, then up to four projects (2 in each category) could be funded at the GLR regional conference. Each project, regardless of the type, that is approved by the Executive Committee will be funded at an amount up to \$1,500.

- 1. Use Special Projects Application (.pdf, click here) as a guide in creating your proposal.
- 2. **Submit completed cover letter with your full proposal**. Submit to the GLR President-Elect at least 30 days before a GLR or AMTA conference.
- 3. **Submit a** *separate document* **for blind review.** In this copy, please do NOT include the cover letter. Also, please remove any identifying information (name of music therapists, facility name, city, etc.) from the proposal. Submit to the GLR President- Elect at least 30 days before a GLR or AMTA conference. This is the copy that will be shared with the GLR Executive Board members; discussion and voting will take place during the GLR Executive Board meeting at the next conference (GLR or AMTA).
- 4. Applicants will be notified regarding the GLR Executive Board's decision within 30 days after a GLR or AMTA conference.

DEADLINE FOR APPLICATIONS: All materials must be submitted to the President-Elect within 30 days before a GLR or AMTA conference. Any questions concerning Special Projects should be directed to the President-Elect of the GLR:

Academic Program Approval Committee—Annual Report

Dr. Cathy McKinney, at-large member on APAC, was appointed by President Ronna Kaplan to serve as Co-Chair of APAC effective June 1, 2011, as part of a transition plan. Marilyn Sandness, who has served as Chair of the former NAMT Education Committee and AMTA Academic Program Approval Committee for 20 years, will serve as Co-Chair until the end of 2011 and then serve in a consultative role to APAC as Chair Emerita in the term of Mary Ellen Wylie to make a future change in leadership as seamless as possible.

APAC has two goals:

- To support the establishment and maintenance of standards of excellence for education and clinical training through collaboration with appropriate association bodies
- To utilize these standards as evaluative criteria for recommending approval for academic institutions

This year music therapy academic programs have been re-approved at 13 institutions and new programs have been approved at four.

GLR Bylaws

BYLAWS Great Lakes Region American Music Therapy Association, Inc.

ARTICLE I Name and Composition

- Section 1. The name of the organization will be Great Lakes Region of the American Music Therapy Association, Incorporated, hereinafter referred to as GLR.
- Section 2. The GLR may authorize state, local and student chapters within its structure.

ARTICLE II Purpose

- Section 1. The purpose of the GLR is to advance and support, on the regional level, the goals of the American Music Therapy Association (AMTA), and to serve GLR members by
 - a. advancing the use of music for restoring, maintaining, and improving physical and mental health;
 - b. training and education music therapists;
 - c. supporting research which advances knowledge of music therapy; and
 - d. providing a forum for the exchange and publication of information about music therapy.
- Section 2. The purpose will be carried out in a non-partisan, non-sectarian manner with equal opportunity being given to all, regardless of race, religion, gender, disability age, veteran status, sexual orientation, ethnicity or national origin.

ARTICLE III Credentials

- Section 1. The GLR will recognize the following professional designation in music therapy: the Music Therapist-Board Certified (MT-BC) credential, the Registered Music Therapist (RMT), the Certified Music Therapist (CMT), and the Advanced Certified Music Therapist (ACMT). The RMT, CMT, and ACMT will expire and no longer be recognized after January 1, 2020.
- Section 2. The MT-BC, RMT. CMT. And ACMT credentials will hereinafter be referred to as professional music therapy credentials.

ARTICLE IV Membership

- Section 1. Membership in the GLR shall be subject to the following conditions:
 - a. membership in good standing with AMTA,
 - b. employment, residence or college/university enrollment in Illinois, Indiana, Michigan, Minnesota, Ohio, or Wisconsin, and
 - c. the member shall not possess voting rights or hold office in any other region of AMTA.
- Section 2. Membership in the GLR will be of five classes: Professional, Associate, Students, Retired Professional, and Honorary Life.

- Section 3. Professional membership shall be open to persons professionally engaged in the practice of music therapy. Such membership will provide the privilege of participation in the activities of the GLR, the right to vote and to receive all issues of the <u>Voice of the Lakes</u>. Only those professional members who hold professional music therapy credentials shall have the right to serve as a GLR officer, a State Representative, or a delegate to the AMTA Assembly of Delegates.
- Section 4. Associate membership shall be open to people not professionally engaged in the use of music in therapy but who wish to support the GLR. Such membership includes the right to participate in the activities of the GLR and the right to receive all issues of the <u>Voice of the Lakes</u>, but does not include the right to vote or hold office.
- Section 5. Student membership shall be open to declared music therapy majors enrolled in AMTA-approved schools or other interested college/university students. Such membership includes the right to participate in the activities of the GLR and the right to receive all issues of <u>the Voice of the Lakes</u>, but does not include the right to vote or hold office.
- Section 6. Retired Professional membership will be open to Professional members who have reached the legal age of retirement, as defined by the Social Security Administration, and whose retirement is a fact. Rights and privileges will be the same as those for Professional membership.
- Section 7. Honorary Life membership may be conferred upon any person in recognition of distinguished service in the field of music therapy. Honorary Life members who qualify for Professional membership will have all the rights and privileges of such membership without the payment of annual dues.
- Section 8. The membership year shall coincide with that of AMTA and shall be from January 1 through December 31.
- Section 9. Members who pay membership dues after October 1 will be considered members from the date their dues are received through the end of the following calendar year.
- Section 10. Rights and privileges of membership will be restricted to those who are in good financial standing with the GLR.
- Section 11. Annual dues shall be 15 dollars for professional members, 15 dollars for associate members, 7.50 dollars for retired professional members, and 7.50 dollars for student members, payable through the AMTA National Office.
- Section 12. Members failing to pay dues by April 1 shall forfeit all rights of membership, including receipt of the <u>Voice of the Lakes</u>.
- Section 13. Persons who have forfeited rights of membership as a Professional, Associate, Retired Music Therapist, or Student because of non-payment of dues shall be able to reinstate themselves with payment of dues for the current period.

ARTICLE V Officers

Section 1. The officers in the GLR shall be elective and appointive.

Section 2. Officers must hold Professional membership in the GLR and a professional music therapy credential.

- Section 3. The elective officers of the GLR shall be President, President-Elect, Vice President, Vice President-Elect, Recording Secretary, and Treasurer. Elective officers have the right to vote at Executive Committee meetings.
- Section 4. No elective officer with the exception of the Secretary and Treasurer shall hold the same office for more than one consecutive term.
- Section 5. The appointive officers of the GLR shall be an Archivist, Editor, and Student Coordinator.
- Section 6. A Student Representative, elected by the student members of the GLR, will serve as an officer.
- Section 7. Duties
 - a. The **President** will preside at Annual Conferences of the GLR; call and preside at meetings of the Executive Committee; appoint, with the approval of the Executive Committee, all appointive officers and all standing and special committees, designating the chairperson of each special committee; be an ex-officio member without the right to vote of all committees, except for the Nominating Committee; conduct GLR Executive Committee and general business meetings; and submit a written summary of the AMTA Annual Conference to be published in the <u>Voice of the Lakes</u>.
 - b. The **President-Elect** will assist the President as requested; study the duties of the President in order to be prepared at the suitable time to take over the responsibilities of the President's office; and assume all duties of the President in case of the resignation, disability, or absence of the President. The President-Elect will annually review the Bylaws, bringing recommendations for amendments to the Executive Committee; will chair the Awards Committee, consisting of the State Representatives, presenting Awards at the annual conference; and will receive Special Project proposals, serving as liaison with the project director and assisting the project director in completion and reporting of the results.
 - c. The **Vice-President** will serve as Program Chairperson, taking responsibility for program planning for the Annual Conference, conferring on all details of management with the Chairperson of Arrangements (Local Program Chairperson) and special conference committees, supervising the finances of the conference participants and submitting their contributions in manuscript form. The Vice-President will succeed to the Presidency in case of the disability or resignation of the President and President-Elect; and will assume other duties as may be assigned by the President and the Executive Committee.
 - d. The **Vice President-Elect** will assist the Vice President as requested, study the duties of the Vice President in anticipation of assuming the responsibilities of the Vice Presidency, and assume all duties of the Vice President in case of the resignation, disability, or absence of the Vice President. The Vice President-Elect is elected to serve 2 years as Vice President-Elect and 2 years as Vice President.
 - e. The **Immediate Past President** will serve as Parliamentarian for Executive Committee meetings and be the authority in deciding matters of procedure according to the Bylaws; chair the Nominating Committee and coordinate the updating of the <u>GLR Officer and Representative Handbook</u>.

- f. The **Recording Secretary** will keep the minutes of all general business and Executive Committee meetings; distribute copies to each member of the Committee within sixty days; notify AMTA National Office of newly elected and appointed GLR officers; and assume other duties as may be assigned by the President.
- g. The **Treasurer** will pay all bills authorized by the Executive Committee; keep an itemized account of all receipts and disbursements; present a financial report on request of the President; and present a written report to the GLR at the Spring and Fall meetings.
- h. The **Editor** will publish the <u>Voice of the Lakes</u> Newsletter in the Winter, Spring, Summer, and Fall. Copies will be mailed to all members in good standing of the GLR, AMTA officers, and Presidents and Editors of other AMTA regional organizations. State Editors elected or otherwise selected by each state organization shall provide assistance.
- i. The **Archivist** will keep in a secure place all items of historical interest to the GLR such as programs, newspaper and magazine articles, and correspondence and forward appropriate items to the AMTA Archivist for permanent preservations in the AMTA Archives.
- j. The **Student Coordinator** will serve as a liaison between GLR student members and the GLR Executive Committee and will be accompanied by the Student Representative or his/her designee at GLR Executive Committee meetings. The Student Coordinator will serve as the GL Representative to the AMTA Student Affairs Advisory Board.
- k. The **Student Representative** will serve as a liaison between AMTAS and the GLR students, and between the GLR students and professional members. The Student Representatives will keep the GLR Executive Committee informed of student interests, needs, and concerns, and work with the Student Coordinator and local Conference Chair(s) to plan student oriented sessions and activities at the annual conference.
- Elective officers, upon retiring from office, will arrange to confer with their successors during the Annual Conference of the GLR to clarify procedure and responsibilities and will deliver to their successors, within two weeks, all record books, papers, and other property belonging to the GLR. Outgoing appointive officers will send all similar materials to their successors with two weeks of being notified of their successor's appointment.

Section 8. Terms of Office

- a. The elective officers of the GLR will be elected for a term of two years. Their terms of office will begin at the conclusion of the final General Membership meeting of an Annual Conference in an odd-numbered year.
- b. The appointive officers of the GLR will be appointed for a term of two years by the President, with the approval of the Executive Committee, during the first month following an Annual Conference in an odd-numbered year. Appointive officers may hold the same office for more than one term at the discretion of succeeding administrations.
- c. The Student Representative will be elected for a term of one year. The term will begin at the conclusion of the last general business meeting at the annual conference.

Section 9. Vacancies

- a. Any vacancy existing in an elective office at the time of an Annual Conference during an odd-numbered year will be filled by an election held during the annual Conference.
- b. Any vacancy occurring during another time may be filled by Presidential appointment with Executive Committee approval to complete the prescribed term of service.

ARTICLE VI – Meetings

- Section 1. The Executive Committee will determine the place and time of Annual Conferences.
- Section 2. A special meeting of the GLR may be called during the Annual Conference at the discretion of the Executive Committee.
- Section 3. The President may call a special meeting of the GLR if requested by four members of the Executive Committee, or upon the signed petition of members in good standing of the GLR.
- Section 4. The President, upon the joint request of not less than three members of the Executive Committee, may call a special meeting of the Executive Committee.
- Section 5. Executive Committee business will be transacted via various means such as e-mail, fax, mail ballot, or conference telephone call.

ARTICLE VII – Committees

Section 1. Executive Committee

- a. The Executive Committee will consist of thirteen voting members: President, President-Elect, Immediate Past President, Vice President, Vice President-Elect, Recording Secretary, Treasurer, and the six State Representatives. The Archivist, Editor, Student Coordinator, and Student Representative will be ex-officio members without the right to vote.
- b. A member will serve on the Executive Committee in only one of the following capacities: (1) elective officer, (2) appointive officer, (3) State Representative, or (4) Student Representative.
- c. The Executive Committee will have the power to transact the general business of the GLR, will be responsible for the control of its funds, and will be empowered to appoint assistants to any officer of the GLR.

Section 2. Financial Committee

- a. A standing Financial Committee, consisting of the Treasurer and two elected officers appointed by the President with Executive Committee approval, will review the GLR accounts on, at least, an annual basis.
- b. The Financial Committee will review and approve the proposed budget to be presented to the Executive Committee in the spring.

Section 3. Nominating Committee

- a. If the Immediate Past President cannot serve as chairperson of the Nominating Committee, the President with Executive Committee approval will appoint some other experienced officer. The President, however, may not serve on this committee in any capacity.
- b. The Nominating Committee will consist of the Chairperson and the six State Representatives or a representative's designated alternate.
- c. The Nominating Committee will contact the total membership in locating potential leaders, contact recommended candidates for their consent to be nominated, and propose a slate of nominees for elective offices to the GLR membership.
- d. Nominations from the floor at an Annual Conference business meeting will be taken before the slate is finalized. Background information and consent of the additional candidates must accompany such nominations.
- e. The Nominating Committee will facilitate the biennial election.
- f. A simple majority, which must include the chairperson, of the total committee will constitute the needed quorum for determining the slate of officers.

Section 4. Awards Committee

The Awards Committee will be chaired by the President-Elect and comprised of representatives from the six state organizations.

ARTICLE VIII – State Representatives

Section 1. Each state in the GLR will elect a Representative to serve on the GLR Executive Committee.

- Section 2. State chapters will elect their respective representatives and alternates and notify the GLR President and the GLR Chairperson of the Nominating Committee within 2 months of the conclusion of the election.
- Section 3. Each State Representative will serve as a liaison between GLR members of the state and the GLR Executive Committee, assist in conducting the business at hand and carry out any duties assigned by the President and the Executive Committee.
- Section 4. The State Representatives will be elected or otherwise selected by each state organization. State Representatives may be selected for succeeding terms at the discretion of each state chapter.
- Section 5. The State Representatives will hold professional membership in the GLR and a professional music therapy credential.

ARTICLE IX – Biennial Elections

- Section 1. The Nominating Committee will propose a slate of nominees to the membership before the end of the last session on the day preceding the final business meeting of the Annual Conference in an even-numbered year. At the final business meeting, the final ballot will be determined from the Nominating Committee slate and additional nominations from the floor.
- Section 2. Ballots will be mailed to the voting members of the GLR, to be returned by the date on the ballot, which is 21 days from the date the ballot is sent.
- Section 3. The counting of election returns will be done in a manner that preserves the anonymity of the voters.
- Section 4. The Nominating Committee Chairperson and at least three other tellers selected, when possible, from members of the Nominating Committee or their alternates will count ballots. If necessary, local professional members of the GLR in geographic proximity to the Nominating Committee chairperson may serve as tellers.
- Section 5. The requirement for election will be a majority of the votes cast. If no candidate for a given office receives a majority of the mail ballot votes, a second mail ballot of the two candidates receiving the highest number of votes will be taken.
- Section 6. The election results will be published in the Voice of the Lakes in an even-numbered year.
- Section 7. Returned ballots and the election report will be sealed and retained in the files of the Nominating Committee Chairperson for a period of six (6) months following the subsequent election.
- Section 8. The terms for elected officers and appointed positions will be extended to the length of 3 years during the years 2008 to 2011.

ARTICLE X – Representatives to AMTA

Section 1. Assembly of Delegates

- a. Primary and alternate delegates will be elected to represent the GLR on the AMTA Assembly of Delegates. The number of delegate positions will be determined each selection year by the AMTA Executive Board.
- b. Primary delegates or their alternates will attend all Assembly meetings held during the AMTA conferences and perform other duties as assigned to them by the Assembly.
- c. Primary and alternate delegates will hold Professional membership in the GLR and posses the appropriate professional music therapy credential as defined in Article III, Section1.
- d. The delegates will meet at three consecutive AMTA conferences. At the conference immediately following the election, they will serve as Assembly Delegates-Elect. The following two years, they will represent the GLR as Delegates to the AMTA Assembly.

- e. Election as a primary delegate will be by a plurality of votes cast. Alternate delegates, equal in number to the primary delegates, will also be elected by a plurality vote. In the case of a tie determining the last primary delegate, the candidate whose last name has alphabetical priority will serve as the primary delegate.
- f. The election results will be reported to the AMTA National Office by June of an odd-numbered year.
- g. Alternate delegates will serve in place of primary delegates according to the order of their election. Having exhausted the list of alternate delegates, the President may appoint temporary alternate delegates.
- h. Prior to the first Assembly meeting, the President will appoint a delegate to report Assembly actions to the GLR membership.

Section 2. AMTA Standing Committees and Boards

- a. A representative of the GLR will serve on each AMTA Standing Committee, attend the specified meetings, and perform duties as assigned by the committee chairperson.
- b. Representatives to Standing Committees will hold Professional membership in the GLR and possess the appropriate professional music therapy credential. Holding a GLR office will not prevent a member from having the opportunity to serve on a Standing Committee. Standing Committee members may also serve on the Assembly of Delegates.
- c. The GLR President, with Executive Committee approval, will appoint standing Committee representatives.
- d. A Professional member of the GLR will be appointed to the AMTA Judicial Review Board and will perform duties as assigned by the Board's chairperson. The GLR President, with Executive Committee approval, will appoint the Judicial Review Board member.
- e. The Student Coordinator will serve on the AMTA Student Affairs Advisory Board, attend its meetings, and perform duties as assigned by the Board's Chairperson. The Coordinator will hold professional membership in the GLR and a professional music therapy credential. The Coordinator will be appointed by the GLR President, with Executive Committee approval. An alternate may be appointed to serve in the absence of the Coordinator.
- f. The term of service on AMTA standing committees and Boards will be two years to coincide with the terms of AMTA officers. GLR representatives to these committees and boards may serve more than one term in succession subject to the appointment or at the discretion of the incoming President.

ARTICLE XI – Quorum

- Section 1. Seven voting members of the Executive Committee, four of whom must be elective officers, will constitute a quorum for an Executive Committee meeting.
- Section 2. A Quorum of the Executive Committee plus five percent of the active membership in the GLR will constitute a quorum for business meetings. At no time will a lack of quorum at a non-business meeting prevent those present from proceeding with the program of the day.

ARTICLE XII – Official Publication

The official publication of the GLR will be the Voice of the Lakes.

ARTICLE XIII – Auxiliary Organizations

- Section 1. The GLR recognizes the state music therapy chapters from Illinois, Indiana, Michigan, Minnesota, Ohio, and Wisconsin as auxiliary organizations. These organizations will conform to the requirements for auxiliary organizations as specified in these Bylaws.
- Section 2. A small group of GLR members desiring recognition as an organized subdivision of the GLR will prepare bylaws patterned after the AMTA and GLR Bylaws. The new bylaws will be presented for approval to the GLR Executive Committee. If that Committee gives its approval, the GLR President will so inform the AMTA Executive Board. Current copies of the auxiliary organization's bylaws must be sent to the GLR President-Elect.
- Section 3. The Great Lakes Region of the American Music Therapy Association Students (**GLR-AMTAS**) is the official student organization of the Association and will conform to the requirements for auxiliary organizations as specified in the Bylaws.

ARTICLE XIV - Affiliation Agreement with Canadian Music Therapists

- Section 1. Canadian music therapists from provinces contiguous with the GLR, who are members of AMTA, will qualify for GLR membership comparable to that which they hold in AMTA.
- Section 2. Canadian music therapists from provinces contiguous with the GLR who are not members of AMTA may apply to the AMTA national office for GLR Associate membership.

ARTICLE XV – Fiscal Year

The fiscal year will be from July 1 through June 30.

ARTICLE XVI – Parliamentary Authority

- Section 1. The current edition of Roberts Rules of Order Newly Revised will be the authority for all questions of parliamentary procedure not covered by these Bylaws.
- Section 2. The presiding officer will appoint a Parliamentarian for business meetings.

ARTICLE XVII – Amendments

By laws may be amended at any general business meeting by two-thirds vote of eligible voting members present, the proposed changes having been announced at least twenty-four hours prior to said session.
